PRARAMBH

This project was launched in the year 2018 with a mission and vision to educate, empower and encourage the educational institutions and students for the two major projects of RNisarg:

Follow the Monkey (Waste Management Project)
S-Miles (Road Safety Project)

More than 25 educational institutions are registered under Prarambh, which is providing an outreach of 50,000 students and staff, and a reach to 6 lakh citizens across multiple cities.

S-MILES: SAFETY FOR MILES

The implementation and awareness are done through skits, pledges, posters and active participants of the citizens in the locality.

Know Your Plastic Contest Rnisarg Foundation in collaboration with Maharashtra Pollution Control board conducted competion on Plastic education. The motive was to make students aware about plastic, and to check their knowledge about the same. More than 1000 Students registered and participated. The winners received hampers and exciting prizes.

SAKHI

Launched in 2019, Proehct Sakhi is aimed to promote a waste free menstrual practice and support women in living a healthy lifestyle.

RNisarg creates awareness & support women to make sustainable menstrual product choices for themselves.

Also, menstrual waste is a burning environmental issue since large numbers of women are switching to use disposal-able sanitary pads, and commercial disposable sanitary pads which are available in the market are non-biodegradable, thereby causing pollution in air, soil and water.

Women of urban slums of Thane, Rural areas of Satara Adivasi Areas of Karjat and Palgar were supported thorugh this project.

GREEN PHARMACY

It is well known that pharmaceutical products which are made for human health should not cause harm to the environment because of unsafe disposal. The strict safety rules applied for drugs meant for human consumption should be extended to expiry drugs and its packaging too. For the safe disposal of unwanted, expired and unused medicines from households, a pilot project under Swacchta Saarathi fellowship, Govt of India is being done in Thane city.

RNisarg joined hands with local bodies to distribute oxygen concentrators, and provided doctor support for COVID helpline.
